## RCU CONSTITUTION

As amended on 27 February 2013

“10.4 The age of elected members shall be determined by the age of the person on 1st July of the year in which the Annual General Meeting is held”

<b>AGE GROUP</b>	<b>FOR 2019 /2020</b>	<b>VACANCIES</b>
Under 25 years	those born on or after 02/07/94	15
Over 25 Years and under 35 years	those born between 01/07/94 and 02/07/84	30
Over 35 years and under 45 years	those born between 01/07/84and 02/07/74	40
Over 45 years and under 55 years	those born between 01/07/74 and 02/07/64	25
Over 55 years	those born on or before 01/07/64	20

"12.2 Any two members belonging to each age group may submit a nomination paper proposing the names of not more than 5 candidates belonging to the same age group for election."

"12.11 A member may vote at an election to the Council of the Union, for candidates of his age group only."

"12.12 A ballot paper which contains more votes than the requisite number to be elected for each age group shall render the entire ballot paper invalid."

"12.13 The Election Committee shall conduct the election to the Council of the Union and all decisions of the Election Committee shall be final and conclusive.”
